Birsa Munda Jayanti 2025

Jharkhand Foundation Day

- Jharkhand was formed on **November 15, 2000**. The Bihar Reorganization Act established Bihar as the **28th state of India**.
- The demand for a separate state had been a long-standing one, rooted in protecting the tribal population's rights and identity in the Chota Nagpur Plateau and Santhal Pargana regions.
- Movements led by organisations such as the Jharkhand Mukti Morcha (JMM) gained momentum post-independence, calling for socio-economic development and self-governance. The state's creation under the Bihar Reorganisation Act, 2000, marked the fulfilment of a decades-long struggle for recognition and representation.



World Diabetes Day 2025

- World Diabetes Day, observed every year on 14 November, is a global initiative aimed at raising awareness about diabetes. The theme for 2025—"Diabetes Across Life Stages"—highlights how this chronic condition impacts individuals at every point in life, from early childhood to old age.
- Diabetes is a chronic health condition where the body cannot regulate blood sugar effectively. This happens either due to lack of insulin—a hormone that helps cells absorb glucose—or because the body's cells become resistant to insulin. Over time, high blood sugar levels can damage organs like the heart, kidneys, nerves, and eyes.

Govt Unveils ₹1,500 Crore Projects

- The Central Government has announced a significant investment of ₹1,500 crore for the modernization of the New Mangalore Port in Karnataka. - Located on the west coast of India, the New Mangalore Port is one of the country's 12 major ports.

- Acting as a logistics hub for coastal and international trade routes

- Eco-education and awareness
- Sunapur Beach (Ganjam District)
- Third consecutive year of certification

- Known for its pristine sand, river-bay confluence, and community-led conservation efforts

India Emerges as the World's 6th-Largest Patent Filer

- In a significant update to India's innovation story, Union Minister of State for Science & Technology, Dr Jitendra Singh, announced that India has emerged as the world's 6th-largest patent filer, with over 64,000 patents filed, of which more than 55 percent are by resident Indian innovators.
- He made this declaration while speaking at an annual tech-fest in New Delhi, also pointing out India's rise in the Global Innovation Index (GII) from 81st to 38th over recent years.
- India has filed over 64,000 patent applications, placing it among the top global innovators.

- More than 55% of these filings are from Indian residents, indicating a shift from mere consumption to genuine innovation.
- India's ranking on the Global Innovation Index has improved dramatically—lifting its standing in the global innovation ecosystem.
